Based on God’s Word in 1 Corinthians 11:23-32 we also believe that anyone who eats and drinks without believing the Body and Blood are present eats and drinks judgment on himself, and further, that receiving the Sacrament at an altar is a public statement of agreement with everything confessed by that congregation. For these reasons we ask **guests** who desire to commune to speak with the pastor before the service. Diluted wine is provided in the center ring of individual cups for those who need or prefer less alcohol. If you need Pastor to commune you at your seat talk with an Elder before the service.
